Steve Smith, 69, of KOLEEN, formerly of Indianapolis, passed away at 10:00 p.m. on Wednesday November 1, 2006 at his home. He was born August 18, 1937, at St. Francis Hospital in Beech Grove, In., the son of Leland (Bud) & Mabelle (Vise) Smith. He was active in the Boy Scouts & DeMolay, Master Counselor in 1954. He graduated from Beech Grove High School in 1956 and attended Hanover & Franklin Colleges. An avid fan of aviation, he received his private pilot license in 1961. He served in the Air Force Reserves from 1961-1966, with active duty during the Cuban missile crisis in 1962. Steve was a member of the Beech Grove Masonic Lodge # 694, Scottish Rite, Murat Shrine Temple & Past President of the Flying Fezzes. In 1995 he retired as co-owner of Smith Packing Company in Indianapolis, a meat business started in 1935 by his father & grandfather. He has lived near KOLEEN since 1996 and raised beef cattle.
